## **Handicap:**

This Tournament will be USBC sanctioned. Handicap is 90% of 220. Last years (2016-2017) highest book average will be used. No average, no problem. An average of 150 for men and 135 for women will be used.

## **Prize Money Payout**

Total Pinfall with Handicap will determine finishing positions. 1<sup>st</sup> Place = 40% of prize fund, 2<sup>nd</sup> Place = 25%, 3<sup>rd</sup> Place = 16%, 4<sup>th</sup> Place = 11%, and 5<sup>th</sup> place = 8%. If there is a tie in a cashing finishing position, both position monies will be added together and then split 50/50 amongst the two teams. Approximate payout of 1 in 5.

For the singles side event, the Highest Individual Game with Handicap will receive \$20, Highest Individual Scratch Game will receive \$20. Remaining singles event prize money will split as follows; 1<sup>st</sup> Place Handicap Series 30%, 2<sup>nd</sup> Place 15%, 3<sup>rd</sup> Place 5%. 1<sup>st</sup> Place Scratch Series 30%, 2<sup>nd</sup> Place 15%, 3<sup>rd</sup> Place 5%.
